-82	December 3, 2009	The elections official will designate a measure letter at the Elections Office at 11 a.m. on this date. <i>EC §§13112, 13116</i>
-78	December 7, 2009	Primary Arguments due. 10-calendar day review period begins at 5 p.m. <i>EC §§ 9501-03</i>
-75	December 10, 2009	End of 10-calendar day review period for resolution.
-68	December 17, 2009	End of 10-calendar day review period for Primary Arguments at 5 p.m. <i>EC §§ 9501-03</i>

-12	February 11, 2010	Second Pre-election campaign report statement due. <i>GC §84200.8</i>
-11	February 12, 2010	County may begin processing of Vote by Mail Ballots on this date. This process may be completed to the point of placing the ballot information on computer tape, but under NO circumstance shall a vote count be made before the polls close at 8 p.m. on Election Day. <i>EC §15101(b)</i>
0	February 23, 2010	Election Day - Mail ballots must be returned to county elections official no later than 8 p.m. in order to be counted. <i>EC §§1000 3020, 4103</i>
28	March 23, 2010	Last day for County to certify election results to district. <i>EC §15372</i>
