## Rebuttal to Argument in Favor of Measure DD

We all agree that providing affordable, quality, safe preschool is important and that the current options are too expensive with inadequate accommodations.

However, Measure DD will not solve these challenges; it creates more complications. It is poorly written, contains significant flaws and is full of unintended consequences that will put our kids at risk, hurt small, minority businesses, and negatively impact South San Francisco.

## Vote No on Measure DD because:

- It's unsafe: it does not require childcare providers to obtain state licenses or adhere to health and safety guidelines.
- It doesn't provide preschool for all: the City's economic report shows that the
  measure won't provide enough preschool seats for South San Francisco residents.
- It's bad for taxpayers: it has no guidelines or oversight on how providers can spend money.
- It's a huge tax: it will raise \$56 million per year almost half the city's \$122 million budget – without addressing some of our most pressing needs, such as affordable housing and public safety.
- It hurts small businesses: it taxes large corporations but also small minority and women-owned businesses who can't absorb this huge tax.

South San Francisco has a Childcare Master Plan to address the rising need for care. Measure DD was placed on the ballot by outside interests and won't solve our childcare challenges. We need to expand childcare in South San Francisco, but it must be done in a safe and affordable way.

Keep our city and kids safe - Vote No on Measure DD.
