In 2012, San Mateo County voters overwhelmingly approved funding that has dramatically improved our county, through fiscally responsible investments in:

- Improving 911 emergency dispatch, fire and police services
- The Big Lift preschool program, addressing early learning and the literacy gap
- Homelessness prevention and food bank funding
- Low-income health care at Seton Hospital and the Mobile Health Clinic at the Coastside \\
- Reducing childhood poverty and child abuse
- Upgrades to county parks from the Bay to the Ocean
