ARGUMENT IN FAVOR OF MEASURE W

We have carefully read Measure W – the Rockaway Quarry initiative— and we strongly encourage you to vote Yes!

Any vote concerning the Quarry is important to Pacifica. We encourage all Pacifica residents to <u>read the</u> measure for yourselves.

You will see that Measure W is a thoughtful approach; ensuring our community will benefit from permanent open space; <u>limited development</u>; <u>significant new tax revenue</u>; and <u>needed traffic mitigation</u>.

Here is what Measure W does:

- Requires any development at the Quarry to preserve <u>75% of the property as permanent open</u> space.

- Requires any building at the Quarry to use green building standards.
- Ensures that before any building at the Quarry, the developer must conduct a complete traffic study, pay all traffic fees, and mitigate any significant traffic impacts.

- Require at least 25 residential units be live-work; reducing traffic impact.
- Require at least 20% of remaining units be <u>affordable</u>; helping with housing costs.
- Require the developer to reclaim the old mining site so <u>hillsides are stabilized</u>, <u>wetlands</u> restored, and <u>invasive species removed</u>.
- Allows for a new hotel/retail center which will bring significant new tax revenue to the City.

It's equally important to understand what Measure W does not do. As clearly laid out in the City's official report:

- Measure W does NOT rezone the Quarry.
- Measure W does NOT approve any development.
- Measure W does NOT take away your right to vote.
